Dear Fellow Members:

We are excited about the upcoming swim season at your Fort Thomas Swim Club. The pool will open on Saturday, May 28, 2011 and will close on Labor Day, Monday, September 5, 2011.

Again this year, we are offering five (5) guest passes to those members who pay their dues before April 1, 2011 (your envelope must be date-stamped by the post office on or before 3/31/11). Dues are still due by May 1, but we are offering this incentive to get dues in on time. Please remember that all guests must be accompanied by a member and if a guest is going to meet you at the pool, let the gate worker know that they are coming. Also, please inform your guests of the rules and regulations of the Swim Club before inviting them. A copy of the Rules and Regulations is enclosed.

Please don't forget, whenever our Club hosts a swim/dive meet at home, our members are entitled to use the pool facilities at the competing team's pool. The area swim clubs that participate in NKSL are Five Seasons, Taylor Mill, Beechwood, Bluegrass, Brookwood, Oakbrook, and Ludlow.

Again this year we will be offering water aerobics classes free to our members (dates and times will be determined later). The Ft. Thomas Swim Club will be offering free swim lessons this summer. Dates and times will be announced.

Enclosed is information for the swim and dive teams along with the registration form. All swimmers and/or divers must have their parents fill out a "Parental Waiver and Release Form", which is enclosed. Please fill it out and send it back with your swimmer's/diver's registration. Swim/dive team is a fun experience that your child will remember for a lifetime. It is also a great way for them, and you, to get involved with the Club and have a great time doing it.

Please determine your annual dues based on the attached schedule and complete the blue Family Status Form. **In order not to incur late fees, both must be returned no later than May 1, 2011.**

Please be aware that late fees are \$50 if your dues are received between May 2 and May 14. If your dues are received after May 14, an additional late fee of \$75 will be charged (total late fee could = \$125). You will also be billed an additional \$6.00 for each late fee certified mailing. It is very important that you let me know if you have moved because ***all packets are sent bulk mail and the post office will not forward them.*** Therefore, if you know someone who has moved over the winter, please remind them to let me know immediately so that they can get their packet and avoid costly late fees.

Should you decide to terminate your membership, your certificate or a notarized Statement of Lost or Destroyed Certificate (enclosed) must be received no later than May 1, 2011 to avoid penalties.
